

1 RHPD MAIN SWITCHBOARD




After opening the RHPD by clicking on the desktop icon the main menu looks as follows:



This screen allows access to the five main components of the database: Entering and viewing data; Entering and viewing other information; Report production; References; and CITES data. Use the mouse for navigation and <Tab> and <Shift> <Tab> to move between boxes.

2 ENTER/VIEW DATA

Select <Enter/View Data> and <Add Record> to reach this screen:



The Enter/View Data screen is divided into four main sections. Document details such as title, year, reliability and authorship are included in the top section; detailed descriptions of specific horn-related information is entered in the middle section; and the bottom section consists of various controls.

2.1 TOP SECTION: DOCUMENT DETAILS

ID# (autonumber)

As soon as you start entering information, the computer will automatically allocate a record identification number. This number should be written on the top right hand corner of the front page of the document for reference purposes.

Country (required)

Type in the two-letter ISO code for the country the document refers to. The computer automatically selects the country as letters are entered. However, in case of uncertainty the drop-down menu can be selected to view the full country names. This two-letter ISO country code should also be written in the bottom right corner of the front page of the document hard copy. It is recommended to file all documents for each country together, in order of ID#.

It should be noted that one particular document may have rhino related information pertinent to more than one country. In these cases, a separate entry (i.e. separate ID#) should be used for each country. This therefore requires a photocopy to be made for each country referred to.

Reliability (required)

This box is used to ascertain the accuracy or reliability of the data, useful in later analyses. Insert 1,2 or 3 depending on the source of data as follows:

- 1 Very reliable source (e.g. government wildlife or enforcement authority)
- 2 Reliable source (e.g. published scientific literature, TRAFFIC)
- 3 Least reliable source (e.g. newspapers, newsletters)

Title (required)

Type the title of the report, book, publication, newspaper article, etc. In the case of returned stock questionnaires or seizure forms, the phrase "Stock questionnaire" or "Seizure form" should be entered. Type 'Untitled' if there is no title.

Year (required)

The year in which the document was written should be entered here. Note that this is not necessarily the same as the year of the actual data itself. For example, a report produced in 2001 may include data from 1999 and 2000. The year should be entered as four digits, e.g. 1999.

Date received

The date of the document is inserted here if applicable. The full date is better known for documents such as newspaper articles, faxes and letters than reports and other publications. The format accepted is day/month/year (e.g. 02/04/00).

Topic

Using the drop-down menu, choose from one of the following options which best summarises the nature of the document:

Captive breeding	Illegal	Museums
Poaching	Populations	Private

Seizures Stocks Stocks & Seizures

If you choose to type in the topic, the computer automatically selects the correct topic as letters are entered. If none of the above apply to the document, another topic can be entered into the database by navigating to <Enter/View Other Information> and <Enter/View Topics> – section 3.

Organisation/Publication

In the case of published information, type the name of the publisher or the name of the journal or newspaper. For unpublished information, the name of the organisation or equivalent should be entered here. Details should include the volume, issue and page numbers, for example:

TRAFFIC Bulletin 14:1(37) Pachyderm 11(23-25)

Document

The type of document is entered here. Generally, documents fall into one of the following:

QuestionnaireFormJournalPublicationDocumentNewsletterNewspaperEmailLetter

Fax Web site Press release

Personal observation Personal communication

On occasion, it is necessary to combine document types, for example 'Questionnaire & Email' or 'Questionnaire and 2 letters'.

Pages


The total number of pages in the document is entered in this space.

Notes

Use this section to include any other relevant document details.

Author

In the top right corner of the document details section, the author(s) details should be entered. Start by entering the surname of the first author and the computer should automatically complete the name as more letters are typed. If the computer does not contain the author details (the drop-down box can be used to help), double-click on the empty space and another box will appear labelled 'Authors'.



Enter the authors' names, nationality and any other notes accordingly. Once completed, close the 'Authors' box and enter the authors' details as detailed above. Repeat the process if the document has more than one author. If the document is not authored, select 'Anon'.

2.2 MIDDLE SECTION: DETAILED DESCRIPTIONS

After completing the document details, specific horn-related information should be entered in the middle section. The number of entries in this middle section is unlimited.



Each entry is made up of three lines.

The first line (inside blue box) is used for more general information:

Description

The first box should contain the most appropriate description of the data. The computer should automatically complete the description as more letters are typed, or alternatively the drop-down box can be used. Choose from one of the following:

Stocks held information on government and private stockpiles Stocks destroyed information on destruction (e.g. burning) of stock

Stocks stolen information on thefts from stockpiles

Stocks returned information on stocks returned, either to stockpiles or

to private individuals following a court case

Stocks sold information on stocks sold legally

Seizures information on seizures of illegal consignments

Dehorning information on de-horning exercises
Found information on rhino horn found
Captive information on captive populations
Wild information on wild populations

Other other information

Poaching information on poaching incidents

Illegal trade general information on illegal trade dynamics

Reintroduction information on re-introductions Exported information on export statistics Imported information on import statistics

Date

Next, enter the year of the data event, e.g. year of seizure; year of survey data. If known, the month and day should also be entered.

Products

This box is used for the item or product being described. For stock and seizure entries, this normally refers to one of the following:

Horn Skin Medicine

Ear Skull Nail Teeth

Alternatively, if the entry refers to a live population, reintroduction or poaching figures, one of the following may be used:

Rhino Black White Indian Sumatran Javan

Number

Enter the total number of items described in the products box above.

Units

Select appropriate units. In the case of stocks and seizures, the most common units include:

Unit Pcs **Pkts**

Bottles Boxes

Other units used in relation to populations include:

Live Carcass

If known, enter the quantity in kilogrammes. Use up to two decimal figures.

Responsibility

The owner or location (in the case of stocks and populations) or agency responsible (in the case of seizures) should be entered here. For example, Pilanesburg NP, Police, Customs, Private sector, Kenya Wildlife Service, etc.

Seizures

The second line of each entry (inside red box) is used exclusively for In the appropriate boxes, detailed information is entered concerning: the location of the seizure; country of origin of seized products; country of destination of seized products; number of suspects; nationality of suspects; mode of transport; and status of case.

Price

Any reference to price information is entered in the third line (inside green box). Information that should be entered here includes:

enter most appropriate units (e.g. kg, pc, animal, etc.) Units Level this is used to represent the level of trade. Use the drop-

down menu to select one of the following:

PO Poacher

Notes


Include any other useful notes in this box, such as other contraband seized, smuggling techniques, names of people, etc..

Superseded entries


In the bottom right of each entry (inside red box) there is a check box which should be ticked if the entry is superseded by an entry from a different document (i.e. different ID#). In many cases, two or more entries from different documents may refer to the same incident; one is likely to be more reliable (see above) or accurate and should supersede the other. After checking this box, the ID# of the more accurate or relevant document should be entered in the adjacent box. This information becomes very important during reconciliation of entries – see section 4.1.

2.3 BOTTOM SECTION: CONTROLS

Finally, at the bottom of the Enter/View Data page, there are various controls that allow you to move forward and backward through documents, add a new record, print the page and duplicate an existing record (useful to save time when one document refers to more than one country).




The <Find Record> function can be used to search through records. Before selecting this function, put the cursor on the field that you want to search, for example the <Title> or <Orgn/Publ>.




3 ENTER/VIEW OTHER INFORMATION

The second component appearing on the main menu allows the user to view, add or modify other important database information including authors, topics and countries.






4 PREVIEW REPORTS

The RHPD has built in numerous queries, some still under development, that are linked to automatic reports. Other queries, not linked to reports, are not included in this version of the operational guidelines (version 1.2). The same applies to data export to GIS applications. These will be covered in a future version of the RHPD operational guidelines.

The main report menu contains four choices: Query by country; Illegal activities; Trade; and Rhino populations.



4.1 OUERY BY COUNTRY REPORTS

A further five report types are Rhino Horn and Product available when <Query bv Database (version 2002.1) Country Reports> is selected. After selecting a report type, the Seizures summary by selected country two-digit ISO country code Seizures reconciliation by selected country should be entered. Stocks summary by selected country Enter Parameter Value X Stocks reconciliation by selected country Which country? tw Country report: all information stored Return to Main Switchboard

The two reconciliation reports (stocks and seizures) are used to reconcile entries in the RHPD, i.e. to ensure that there is no double counting and that the most reliable and accurate pieces of information are recognised.

The data is automatically sorted in order of data description, date and product. This report should then be printed out in Microsoft Word and the reconciliation process is conducted manually. If entries are repeated, tick the box and note the more relevant or accurate reference ID#. Sometimes, a new entry may have to be made to incorporate the details from several other, similar entries. After manually completing the reconciliation process – using the hard copies as reference material – any changes are then made directly in the RHPD using the <Enter/View Data> page. The relevant summary report is then selected from the <Query by Country Report> menu.

This summary report automatically removes the superseded entries (although leaves references to them) and summarises the most up to date information in order of description, year and product. The same process is used for reconciling and printing out summary country reports for both stock information and seizure information.

The <Country Report: All Information Stored> report contains all information pertaining to the chosen country, including reconciled and non-reconciled entries.


4.2 OTHER REPORTS

A further three reports may be selected which present the following information in order of country:

Illegal Activities – all data on seizures, thefts, poaching, intelligence, etc. Trade – legal trade, imports and exports of live rhinos and trophies Rhino Populations – wild and captive numbers, translocations, etc.

These reports allow documents to be indexed rapidly according to author, country or topic:



6 CITES DATA

The RHPD currently contains all CITES permit data from 1973 to 1999 but can be updated automatically from outputs delivered from UNEP-WCMC who manages the CITES permit database on behalf of the CITES Secretariat.



Four reports are produced from this menu, summarising all exports (data presented by both importing and exporting countries), imports (data presented by both importing and exporting countries), confiscated items and all data listed in order of year and taxon.
