## Chairman's view

### Ready for expansion

As we fast approach 2012, I can report that Rhino Ark is poised and well prepared to move into an exciting phase of expansion.

Our promise to focus our conservation efforts on the ecologically precious indigenous mountain forests and their total habitat, working closely with those communities which live in their shadow, remains on track.

We have set aside funds to start the actual fence construction in Mt Kenya and Mau Eburu – both of which are planned to begin in the first quarter of 2012. These huge projects will require funds totaling Ksh 1.1 billion and we have set a time frame of five years to secure the funds and complete the work.

We have made agreements with the Kenya Wildlife Service as our construction partners for the actual build process. We are engaging with a range of stakeholders – the principal being the Kenya Forest Service who have been one of the main beneficiaries of the fencing concept in the Aberdares – to enable more effective management of mountain forests exposed to illegal logging and excisions.

In Mau Eburu we are working closely with the Interim Co-ordinating Secretariat (ICS) in the office of the Prime Minister which has overall authority for the Mau Forest complex.

We are currently in the mobilization stage when all materials need to be ordered, machinery and vehicles purchased and the build team put together.

We already have a total of Ksh 128.6 million to start the build process and there is increasing interest being shown to support the funding at all levels in Kenyan society, by bilateral agencies and friends of Kenya overseas.

Finally, we remain fully committed both financially and as founder members of The Aberdare Trust – the body now legally established to manage the Aberdares fence into the future.

The terms of the Trust include playing a policy-forming role to ensure holistic management, guided by sound conservation principles, of this highly valuable 'water tower'.

As Rhino Ark takes on these new projects and remains in the Aberdares, its core management structure is firmly in place to assume these new challenges. In addition it is investing in a broader management structure to take it to new heights.

Rhino Ark enables the public to participate in the establishment of a fully structured, soundly funded body that will play an influencing role in managing Kenya's 'water towers,' and as partners with their managing agency parastatal bodies. Together we will secure them for posterity. Together we will enable them to deliver their services, products and biodiversity values for the public good.

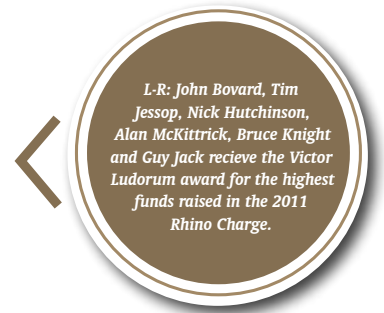

# FUND RAISE FANATICS KEEP BREAKING RECORDS



**25 cars each delivered over one million shillings at the 2011 Rhino Charge in Yatya, Baringo breaking a new fund raise held record.**

The first single millionaire Rhino Charger was Guy Bishop who with his wife Bella raised Ksh 1,325,028 – a mind boggling achievement at the time which brought huge cheers at the 1994 prize giving ceremony in Parkitapu, Mara region.

Since that first breakthrough, the millionaires 'club' has never looked back.

Breaking into it was not easy in the early days of Rhino Charge.

It was Stefano Cheli who was the first to make a million two years running (1995/96). Then the formidable fund-raise 'machines' of the late Mike Higgins with his wife Sarah in the 'shamba' Lada swept into the forefront dominating the top millionaire slot for five years (1996-2000) before they were over taken by Car 5 and the McKittrick team in 2001. But again the Higgins team took the crown back for one more year in 2002 before Car 5 took the lead in 2003 and has dominated the ever growing numbers of millionaires each year ever since.

The number of millionaires accelerated after 2003 as Rhino Ark's message calling for total mountain ecosystem conservation of water, trees as well as wildlife attracted public attention.

This was a turning point.

By 2005 the millionaires had increased to 18-20 cars and in 2010 the total accelerated again to 24 and now to 25 millionaires in 2011.

In 2010 Car 5's success cutting through the over Ksh 10 million threshold drew huge acclaim, only to witness an even higher Ksh 11,509,915 this year.

There are several teams snapping at Car 5's heels including Car 10 the American Wags with over Ksh 4 million (2009) and the Car 35 Hog Charge team, which has consistently raised over Ksh 3 million since 2008.

In 2012 the Car 10 Wags of McKenna/Welles are again ones to watch as they try to dislodge Car 5 from its seemingly unassailable position to date.

In 2011 special acclaim goes to new millionaire entries: David Bromham/ Michael Turner Car 15 (Ksh 2.34 m); David Percival Car 46 (Ksh 1.26 m); Ramesh Vishram Car 16 (Ksh 1.123 m); Grant Mowat/Proudly Nigerian Car 32 (ksh 1.01 m); the Zambians of Peter Castle team 14 (Ksh 1,073 m); Rally are Ian Duncan Car 2 (Ksh 1,058 m) and new entrants Rajesh Maini Car 34 (Ksh 1 m).

Behind each of these entries – indeed all the entrants – are thousands of supporters who have selflessly sponsored the chargers in a truly national commitment to conserve our mountain forests.

Rhino Charge remains Kenya's unique combination of sport, great driving and team skills both in the event and in the fundraise effort.



## Haworth - A Trustee

## The Aberdare Fence has Improved Livelihoods, Land Values and Biodiversity, says new study.

**It is worth KES 59.3 billion (US\$ 630 million) annually in services and biodiversity.**

**The now completed 400 km electrified fence enclosing the Aberdare Conservation Area (ACA) has improved the livelihoods of millions of people in central Kenya, according to an independent study launched at the United Nations Environment Programme (UNEP) headquarters in Nairobi on 5th September 2011.**

The study, *The Environmental, Social and Economic Assessment of the Fencing of the Aberdare Conservation Area*, attributes improved forest cover, safer living conditions for local communities and greater security for wildlife to the fence, which was completed in 2009 after 20 years of construction.

The study was requested by The Rhino Ark Charitable Trust, the Kenya Conservation Charity that has pioneered the fence project, with funding support from thousands of Kenyans and friends of Kenya overseas. The study was co-funded by UNEP, Rhino Ark and Kenya Forests Working Group and supported by the Kenya Wildlife Service, the Kenya Forest Service and the Greenbelt Movement.

Speaking at the launch, Achim Steiner, UN Under-Secretary-General and UNEP Executive Director, said: "The Aberdares conservation efforts underline the extraordinary and wide-ranging returns possible when a more creative, decisive and sustainable approach to managing nature is undertaken - they also offer a model for exemplary public-private partnerships."

"Indeed Kenya's new policies on renewable energy to conservation of its water towers including the Mau complex, Mt. Elgon, Mt. Kenya, the Cherangany, and the Aberdares, is demonstrating practically and politically that a transition to a Green Economy is as relevant to a country in Africa as it is to countries across the world," he added.

Co-launching the study, Colin Church, Chairman of the Rhino Ark Management Committee declared: "The study affirms that the fence has proved a prime management tool in the process of both conservation integrity and ensuring better incomes for all fence-edge farmers, as well as the national and global interests that are derived from the Aberdares as a prime water, forest and biodiversity hot spot."

"The study re-affirms that the Aberdares is offering a management and policy blueprint for the precious 'water towers' of Kenya and other tropical mountain ecosystems upon which so much human resource is increasingly dependent", he added.

Over the last 15 years, UNEP has been highlighting the vital role of Kenya's 'water towers', such as the Aberdare Range and the Mau Forest complex, in securing environmental stability, economic development and human well-being. The financial and technical support to the Aberdare assessment study is part of UNEP's ongoing work in enhancing the understanding of the importance of ecosystem services.

Key findings in the report confirm:

- A 20.6% increase in forest cover between 2005 and 2010:
- A 54% decrease in open areas (grassland and cultivation inside the now fenced 2000 km<sup>2</sup> Aberdare Conservation Area):
- A 47% increase in exotic plantations outside the fenced area.

The report attributes these improvements to the effects of the fence and associated fence management guidelines as well as more assertive policy interventions.

It emphasizes that there should be an integrated management plan for the Aberdares and by inference that future government policy should incorporate holistic approaches to the way high value mountain forest ecosystems are managed.

The study has recorded the socio-economic effects, such as higher household incomes and land values (as high as 300% in some cases) due to improved farmland security, crop yields and safer living conditions. Wildlife crop destruction has been all but eliminated and children travelling to school face fewer risks from animals.

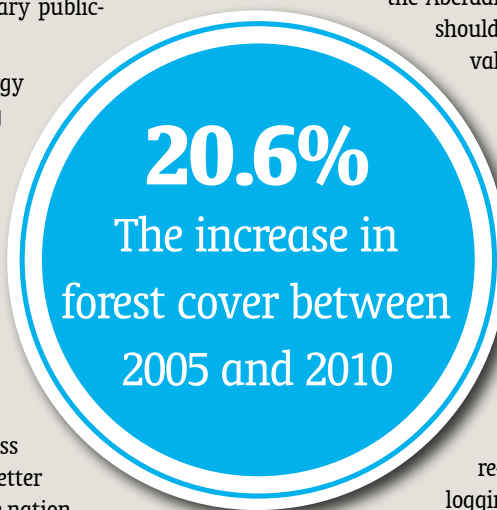
The number of fence-edge communities growing wood lots for farm fuel is increasing. In some areas, communities have initiated indigenous tree re-planting inside the fence where previously illegal logging, uncontrolled cattle grazing and indiscriminate cultivation were rampant.

Cattle rustling using the forest as an escape route has ceased and disease transmission between wildlife and livestock has greatly reduced.

The report confirms that wildlife populations have increased, though poaching remains a threat. It confirms that whilst the fence protects farmers' land, it is not, nor was designed, to be human proof. The report calls for stricter gate access policies to regulate access to the Aberdare Conservation Area and to tackle illegal activities inside the indigenous forest areas.

On water resources, the report says limited data indicates that the Aberdares' rivers are "more stable than the Mount Kenya rivers" – a fact it attributes to better land cover in the ecosystem.

The report's economic analysis gives a breakdown of identifiable benefits provided by the Aberdares to many parts of Kenya. The value of provid-





ing domestic water supply to central Kenya, parts of the Rift Valley and the Tana River valley, for example, is estimated at KES 646 million (US\$ 6.9 million) annually. For Nairobi, where almost all the water supply comes from above and below ground Aberdare sources, the value given is KES 1.46 billion (US\$ 15.6 million) annually.

The Aberdares is a key contributor to hydropower, which represents 58% of the national total installed capacity. The mountain range is a core provider of water for the horticulture and floriculture production around Lake Naivasha and is also vital to the Ewaso Nyiro River, which flows into Laikipia and the arid northern rangelands.

On carbon sequestration and soil erosion control, the report assesses the annual value at just under KES 1.9 billion (US\$ 20.3 million).

Carbon credits account for KES 450 million (US\$ 5 million) annually.

The report stresses important values to fence adjacent communities and key revenues from the Nyayo tea zones and tourism.

Total products and services values are put at KES 39.3 billion (US\$ 420 million) and biodiversity at KES 20 billion (US\$ 214 million) – an overall total of KES 59.3 billion (US\$ 633 million).

The overall distribution of economic benefits from the Aberdares gives the central Kenya/Rift Valley area 71%, whilst the total national benefit is logged at 12%. The fence adjacent communities receive 7.6% of the total cake. The global value from agricultural exports, tourism and biodiversity is just under 7%.

In per capita terms, the 40,000 families whose land borders the fence and gazetted forest line are receiving by far the largest value benefits at KES 14,580 (US\$ 155) per capita compared to a regional figure of KES 4,661 (US\$ 50) per capita.

However, despite these substantial positive changes, the study affirms that the fence is under-supplied in both human and capital needs.

It recommends that the Ministry of Finance be further sensitized as to the value of the Aberdare ecosystem and to provide appropriate budget allocations to its overall contribution to the economy and GDP of Kenya.

The report affirms that a public-private partnership using a trust mechanism should be formed, which would enable stronger ‘participatory management’ by communities with the relevant government agencies. It stresses that there is an urgent need to ensure a properly implemented gate management and access policy for gazetted (vis à vis national park) forest areas.

The report proposes that given adequate financial and human capital support through immediate Treasury funding, the long term financing could be derived from Payments for Ecosystem Services (PES) mainly from water and electricity users. In addition to ensuring ecosystem stability, PES could then be re-directed to accelerate income generating and non-exploitive activities for fence adjacent farmers.

The study recognizes that the fence adjacent communities could place new exploitive pressures on the forests and so need greater long-term support to create income activities that are compatible with conservation.

It concludes by affirming that management of the buffer zone - the five kilometre area around the fence - should be clearly identified and every effort made to create “positive benefits by deliberate investment in support of local livelihoods.”

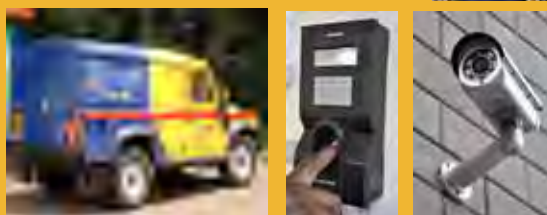

# WHERE EVEN BABOONS FEAR TO TREAD... 'THE FROG' IS NOT FOR TURNING

## A TALE OF 'NEW BOY' CHARGER TAKING 7TH PLACE

Arriving into the dust ridden, loose lave slopes and wait-a-bit brush of Yatya, east of the Tugen Hills couldn't have been more exciting. It was the moment we had waited over a year for.

The 2011 Rhino Charge had finally arrived.

Preparation for the Charge had started back in April 2010, when a rickety old Range Rover Classic was bought with wild ambitions. After talking at length with some of the sports' most experienced and successful competitors to whom I owe a great deal; ideas on modifications from old Volvo portal axles to large V8's, under drives and super sized wheels were born. What eventually emerged was a diesel powered, range rover buggy, we affectionately named 'The Frog'.

Five out of our team of six were new to the event and had no idea what to expect. So when Anton told us in the briefing, in his own charismatic way, that we were to straight line everything, wide eyed and naively we took this to heart. Rushing back to our camp in a beautiful acacia shaded riverbed, we started planning our route for the following day. At 10pm, still scratching our heads, we were no closer to completing this exercise and eventually after some female sense was brought to the table, a plan A and plan B were formed.

Waking up to the sound of V8's roaring as the first competitors set off to their start area at 4:45am got the adrenaline pumping. Upon arrival at our starting Control, Kick Energy, it was apparent that the gentle slope we calculated to be 1m down for every 2m across shown on our trustworthy 1960's map, was indeed a cliff baboons would have struggled to traverse, let alone a 4x4.

Plan B it was.

As our runners set off to start up a route through to our first control, we fell into what turned out to be even more wor-



rying chatter with other teams about which route to take clockwise? or anti-clockwise. More uncertainty crept in when most of the experienced teams had chosen completely different routing and raised concerns over one particular leg; Aon to Copycat - a leg we thought would be one of the easiest! Nevertheless, the hooter went and immediately we were on our own.

Full of energy and confidence, all four runners kept well ahead of the car scouting ambitious routes from the word go. Very soon we were piling through thick wait-a-bit forest thinking The Frog was invincible! On our way into the Brookhouse control, a very steep down slope lay ahead covered in vegetation. 'Baobab', our nickname for Guy, skidded down the slope, tripped and somersaulted over the bush only to say 'its fine, come!' This didn't exactly fill Quent and myself with confidence. But over we went. Crashing into Brookhouse, a huge cheer welcomed us. After some quick refreshments and a reminder to all the runners that we have only a mere 40km's of this; we left for Aon. No more than 200 meters out of the control, crash-

ing through some bush, the dreaded sound of a puncture. I couldn't believe and so early on, especially after hearing from the Avery's that they had run the same tyres for 11 years without incident.

After a very quick change we were in the Aon Control in no time quizzing everyone we could find on the dreaded route ahead to Copycat. 'One vehicle had made it through,' we were told. Good enough for us. Off we went over the hill and towards the gorge. On arrival at the thick scrub encasing the rock stricken lugga, we met a team on their way out. 'Too many big rocks, no way through' was the message as Binks galloped down to have a look for himself. Cries came 5 mins later from the valley below to bring The Frog down.

Nervously, we crept down very narrow goat track that led us down one side of the steep-sided lugga until we were in amongst the boulders. Sand ladders and very low gears proved invaluable here as the bottom of the car took a beating. On exiting, we had noticed that there was a trail of diesel following the car. The steering was getting stiffer. Immediately under the Frog, Binks pointed out that ATF was also pouring out of the seal at the bottom of the steering box. More worryingly, diesel was still leaking. Dread set in as fears of a cracked fuel tank took hold and the horrifying thought that we might not be able to complete the Charge.

Disheartened, we decided to carry on to Copycat to address the issue there. In no time we came across Ian Duncan also enroute to Copycat, powering through soil erosion gullies and thick scrub as though it was a Sunday afternoon drive. After a bit of helpful advice, we followed him into Copycat with our power steering now gone.

To our amazement, the fuel leak had ceased. The gauge was still showing full! A renewed sense of confidence took over when we realized it was fuel coming from the breather. We sped towards The Gauntlet now trying to make up time following the mammoth trails left by the Unimogs. An ambitious route was picked over the sheer rocky hill from KWS and then up to Land Rover. Ian Duncan was following up behind and like us, got stuck on the slope into Land Rover. We connected both front winches and hauled the huge 3.6-ton Land Cruiser up the hill, terrified since we were so light, without a

handbrake on loose surface and my sister on the winch!

Leaving The Gauntlet to Hardy took us up another rocky riverbed where Anna ran eye first into a wait-a-bit, which looked hugely painful. An iced, sheep dip gun to dowse us down and ice creams at Hardy soon renewed the team spirit and we were off down the rocky riverbed to Vineyard. Making up time, Quent must have got sick of the girly yelps each time the steering jarred back on itself beating my hands as we sped over the boulders.

On leaving Vineyard, we were faced with a sheer valley to Satao. We couldn't find a way through and were now, very short of time. Some locals were seen on a ridge above who told us they don't even take their goats through there! Now it was decision time. Do we straight line it and hope for the best or road run to make sure we finish? The latter was chosen which led to us covering 12km on a leg, which as the crow flies, was just 2km. We careered into our final control with 15 mins to spare, happily to find two of the other five teams (car 5 and car 49) that had started had also completed this grueling Charge. Not too long into the celebrations and Car 28, an unmodified Hilux came roaring in driven by Torben Rune. How it was possible to get an unmodified car around that course was beyond me. Full marks to them.

On returning to HQ, news was spreading that only a handful of cars had completed including our good friends the Avery's and Team Sally Slop Cabbage (my mother's

team). This gave even more cause for celebration and as teams came back from the field weary and broken, many heroic stories were swapped at the bar.

We received the results the next day at prize giving. We had come 7th overall, won best rookies and the Gauntlet, which was very unexpected and very special. Even more so, was that my mother's team - with an average age of over 50 - had come in 3rd. That is what makes this event so unique. Youth and exuberance seems to count for nothing. Experience, knowledge and a little luck will get you far.

We will be back next year without doubt to take on what has to be one of the most well organized, exciting and unpredictable event in the 4x4 calendar. All to raise money for a fantastic charity towards preserving some of the last highland forest fauna and flora left in this beautiful country from which so many Kenyans benefit.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2011**

**1. SIGNIFICANT ACCOUNTING POLICIES**

The principal accounting policies adopted in the preparation of these financial statements are set out below:

**(a) Basis of preparation**

The financial statements summarise the transactions of the Trust and deal with the net assets at the disposal of the trustees.

The financial statements are prepared under the historical cost basis of accounting.

**(b) Income recognition**

Donations and Rhino Charge collections are recognised on receipt.

Investment income is recognised on accrual basis.

**(c) Property and equipment**

Items of property and equipment are stated at cost less accumulated depreciation. Depreciation is charged on the straight line basis over the estimated useful lives of the assets.

The annual depreciation rates in use are:

Motor vehicles	25.0%
Furniture and fittings	12.5%
Computers	33.3%
Office equipment	12.5%

**(d) Foreign currency transactions**

Transactions during the year are converted into Kenya Shillings at the rates ruling at the transaction dates. Assets and liabilities at the reporting date, which are expressed in foreign currencies, are translated at the rates ruling at that date. The resulting differences from conversion and translation are dealt with in the income and expenditure account.

**(e) Financial instruments**

A financial instrument is a contract that gives rise to both a financial asset of one enterprise and a financial liability of another enterprise. The financial instruments held by the Trust are investments in the money market, trade and other receivables, bank balances and cash and trade and other payables.

All the financial instruments held by the Trust are accounted for on amortised cost basis.

**(f) Receivables**

Receivables are stated at nominal value, less provision for any amounts considered irrecoverable.

**(g) Cash and cash equivalents**

Cash and cash equivalents comprise cash at bank and in hand and short term deposits with an original maturity of three months or less.

**(h) Use of estimates**

The preparation of financial statements requires that management makes estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates. The more significant estimation process is related to the determination of provision for doubtful debts. Although some variability is inherent in these estimates, management believes that the amounts provided are adequate.

This has been a milestone year for the Rhino Ark Charitable Trust.

It has taken the Rhino Ark Charitable Trust 22 years to build and successfully assist in the daily running of what is recognised as East Africa's longest wildlife conservation fence.

Equally significant is Rhino Ark Charitable Trust's continued active role in raising national awareness as to the threats to the nation's vital mountain 'water towers' that hold some of the country's most precious resources.

Rhino Ark Charitable Trust not only remains actively engaged in providing funds support for the now complete nearly 400 kilometres long Aberdare Fence, but has championed the need for full integrity practices as the process for the long term planning and management of this 2,000 square kilometres mountain forest eco-system unfolds. Formation of The Aberdare Trust continues. This is a pioneering exercise and one which involves various departments of Government. However, I am pleased to report that the process remains on track. It is hoped that finalisation of all the formalities and legal processes will be complete in the 2012 financial year.

In 2010, UNEP, Rhino Ark and the East African Wildlife Society's Kenya Forest Working Group jointly funded an environment assessment to review the fence's impact on the stability, security, integrity and economic well-being of the Aberdare Conservation Area and its forest-adjacent communities. The assessment will be completed in the 2012 financial year.

### Another Record Year

The total funds raised during the financial year under review were KShs 106 million.

Despite the difficult economic times, the 2010 Rhino Charge exceeded expectations and raised at field audit a total of KShs 72,068,902.

Gross donations amounted to KShs 91 million.

For the fourth year running, the Kenya Treasury was our second largest donor providing KShs 15m for fence materials and channelled through our fence construction partners, Kenya Wildlife Service.

### Corporate / Conservation Bodies Support

Corporate and bi-lateral grant supporters continued positively and I would also like to thank the following organisations who have made sizeable contributions:-

- African Fund For Endangered Wildlife (**AFEW**) for donating KShs 6.5 million;
- **Safaricom Foundation** for the Elephant Grid by donating KShs 1,534,285 in this current year, which brings their total donation over the years to KShs 10 million;
- **Rare Species Conservatory Foundation** for donating USD30,000 for human resources and motor vehicles under the Bongo Surveillance Programme.

### Guard Post Construction

A total of KShs 7,067,653 has been spent on the construction of two guard posts in this financial year at Marimu and Geta in the Western Aberdares.

### Launch of Mt Kenya and Mau Mt Eburu

On 8 December 2010, my Board of Trustees approved our plans to fence Mt Kenya and Mau Mt Eburu. Work on these two projects is expected to commence in this financial year and a total of KShs 24 million has been allocated to the projects. KShs 12 million has been allocated in this financial year while a further KShs 12 million will be allocated in the financial year 2012. The Mt Kenya fence will be approximately 400 kilometres and the Mau Mt Eburu will be 50 kilometres long.

### The General Fund

The general fund as reflected in the statement of financial position has been split into two categories namely Fence Maintenance Reserve and Fence Construction Reserve. Twenty percent of each year's Rhino Charge donation is allocated specifically for maintenance of the fence already constructed. This is to ensure that the huge amount of effort and money put into the conservation programme does not collapse from lack of maintenance. The maintenance reserve is, therefore, to earmark these funds for maintenance and not is used for construction.

The fence construction reserve deficit has reduced from KShs 27 million to KShs 22 million. This situation is expected to reverse during the current year. The fence maintenance reserve surplus increased during the year from KShs 47 million to KShs 56 million.

### Bongo Surveillance Programme (BSP) successes

This programme has continued to receive tremendous support from our donors and, in particular, from the **Rare Species Conservatory Foundation**.

### Thousands to thank

It is always difficult to single out thanks in a report like this. Rhino Ark Charitable Trust has thousands of donors in Kenya and friends of Kenya overseas who support our home-grown and home-driven conservation initiative.

I thank all of you.

I wish to specially thank the Rhino Charge Committee and the huge band of volunteers who yearly give so much time, thought, ideas and energy to running this world class, and still world unique, event which consistently raises huge sums of money at its annual event in June for our work.

### Elephant Grids

A ceremony to commission two newly completed elephant grids at the Kipipiri elephant corridor and one at Kieni forest was held on 23 June 2011 at Geta in Kipipiri area. The grids have been fully funded by the Safaricom Foundation at a total cost of Kshs. 4.6 million.

Les Baillie, Safaricom Foundation Chairman, commissioned the grids. The ceremony was attended by members of the local community. Partners Rhino Ark, Kenya Wildlife Service and the Kenya Forest Service were well represented at the event.

The grids are metal and concrete structures built on the ground at the point where the Aberdare electric fence intersects public access roads that traverse the forest. The innovative design of the grids incorporates rolling bars with gaps between them. They are highly effective

in keeping the wildlife at bay, while allowing passage of road traffic. The grids are an example of the safe, win-win type solutions that are characteristic of the Aberdare Fence Project.

“Elephant – indeed all wildlife use the corridor linking the main Aberdare Range with Mt. Kipipiri. It passes through gazetted forest land but close to hundreds of fence adjacent farmers’ land,” explained Colin Church, Chairman of Rhino Ark, as he thanked the Safaricom Foundation for their generous support at the commissioning ceremony.

The Safaricom Foundation has been a consistent supporter of Rhino Ark’s conservation initiatives in the Aberdare ecosystem with almost Kshs 10 million donated to date.

# 800 in schools run for Aberdares

Over 800 school children participated in the just completed 2-week long 400 kilometre the 2nd annual Aberdare Fence Relay Run. The event is organized by Rhino Ark and Kenya Wildlife Service to raise awareness of the Aberdare Fence project and conservation of the Aberdare ecosystem.

Olympic Marathon Champion runner Tegla Loroupe flagged off the run on 14 June 2011 at Bondeni, Mweiga and handed over the relay baton to the first of the 88 participating schools. Schools along the boundary of the nearly 400km long Aberdare fence eagerly participated in the run, with each providing ten pupils and one teacher. Pupils were selected by their schools on merit, either academic or sporting, and this added competitive spice to their participation.

The baton was carried by each school team from its own school, over several kilometres of often hilly Aberdare terrain, and presented to the next participating school. Over the next two weeks, the school children ran, counter-clockwise along the fence, over hills, valleys and mighty rivers, often within sight of the forest and wildlife safe behind the fence. By 30 June, they had completed a massive loop that encircled the 2,000 km<sup>2</sup> ecosystem. Rhino Ark's Eric Kihui and Kenya Wildlife Service Aberdare Education Officer Joyce Kurui received the relay baton from the final school, Amboni Secondary, at the fence line in Bondeni Mweiga.

The Fence Run, now in its 2nd year was received positively by the local communities. Caroline Wangui, a Class 8 Pupil at Talau Primary was among the pupils who took part in the run. Speaking to Rhino Ark afterwards she said, *"If there was no fence, the whole forest would be destroyed, we would have no food and would still live in fear of being attacked by wild animals when going to school or the market. The fence has taught me that if we come together, we can achieve great things – we can take care of our environment for the benefit of all of us."*

## Wangari Maathai - champion of the forests

### **Prof Wangari Maathai always took a close interest in Rhino Ark's progress.**

She was particularly outspoken on occasions when sections of forest being set aside for monoculture commercial wood plantations were the subject of considerable debate between Rhino Ark, KWS and KFS.

When she was Assistant Minister of Environment, Natural Resources and Wildlife from 2002 to 2005, she pressed for the reasons why in 1999, during the Moi Government, that a major section of forest in the Zaina area near Nyeri was excluded. It runs along the Phase Four section and excludes important areas of riverine valley and water catchment.

The 1999 decision to exclude Zaina (and which Rhino Ark had to concede to against its wishes at the time) became the subject of much discussion in 2003 between myself, Wangari Maathai and the Minister responsible for forestry at the time (the late Dr Newton Kulundu) - particularly as unfolding policies under the new Kibaki Government regarding forest integrity and the need to stop excisions were hardening. It was Wangari who was influencing those policies considerably.

Rhino Ark has consistently championed the principle as outlined in the Forest Bill - still in formation at that time - that areas of high altitude water catchment must be conserved as water sources of greatest value to society and not converted to fields of timber for commercial extraction.

It was not until 2005 when the Forest Act finally, became law that such conservation fundamentals stood a better chance of strong political support on the ground.

It remains Rhino Ark's position that the sections along Phase Four, where considerable acreages of precious indigenous forest remain outside the fence, need review. Fences are management tools and

can be moved to improve forest management on the ground.

During 2004 and 2005 Rhino Ark was at its most stretched and challenged time during the entire 20-year construction process. The 82 km long Phase Five was dissected by 22 rivers and 50 streams and springs, each at the bottom of a steep valley. The fence build teams were carrying every piece of construction equipment, often several kilometers, to reach some areas not served by tracks and in an area receiving up to 2000 mm of rain annually.

In August 2005 I asked Wangari to commission Phase Five on its completion in November that year. She enthusiastically agreed. On 24 November 2005 Professor Wangari Maathai was replaced as Assistant Minister for Environment, Natural Resources and Wildlife.

On hearing the news I phoned early that morning to confirm her attendance the next day. She replied: "But I am no longer an assistant minister". I said that I had asked her as the global champion for forest conservation and as a Nobel Peace Laureate. She said she would change her programme and come. When she eventually arrived in her own vehicle, her former permanent secretary, Prof George Khroda accompanied her.

It was an event filled with ululating crowds from the villages around Kihari in Nyeri District where the commissioning plaque remains a testimony to her support for Rhino Ark's conservation drive in the Aberdare Mountains.

## Ksh 128.6 million already committed to Rhino Ark's new projects.

Since announcing the plan to fence Mt Kenya and Mau Eburu on December 8 last year, there has been an outpouring of support from Rhino Chargers, corporations and the Kenyan Government to a total value of Ksh 128.6 million to date.

The target for completion of the two projects is Ksh 1.2 billion over a five-year completion period for Mt Kenya and 18 months for Mau Eburu. The Mt Kenya and Mau Eburu fences will start in 2012.

Materials to the value of Ksh 100 million to start the fence build programmes for Mt Kenya – a World Heritage Site – and the highly endangered Mau Eburu – one of the 22 forest blocks in the Mau Forest Complex - have been committed by the Ministry of Finance in the current annual budget.

In a letter to Rhino Ark signed by the Permanent Secretary of Finance, Mr Joseph Kinyua: *The Government is fully committed and will continue to embrace a holistic approach to environmental management for sustainable economic management.* Rhino Ark's Trustees have confirmed a commitment of Ksh 24 million from the 2010 and 2011 Rhino Charge funds.

Rhino Ark can confirm that the two projects will be undertaken using the existing process of technical partnership agreements with fence build partners the Kenya Wildlife Service and working in close collaboration with the Kenya Forest Service through regular joint meetings.

Resource mobilization and materials procurement is in progress with a plan to start construction work as early as possible in 2012 for both Mt Kenya and Mau Eburu.

## Kariki Primary School spearheads Community Conservation

Kariki Primary School sits in the foothills of the Northern Aberdares Ndaragwa district in Nyeri County, literally minutes from the Rhino Ark Aberdare electric fence. This area of the Aberdares is near where bongo are frequently found. It is the most recent addition to the growing list of schools in the Aberdares that are part of the Bongo Surveillance Project (BSP) Schools Wildlife Clubs.

In October 2011, Rhino Ark's Eric Kihui and Adam Mwangi visited Kariki to present bongo educational materials produced by Rhino Ark and to inspect the conservation activities of the school. The materials, comprising large format posters and brochures, will educate the students and serve as a constant reminder that the bongo remains in peril and that all efforts must be made to conserve the species.

The school's head teacher, Clement Muchemi has described the various conservation initiatives of the school as a notable achievement. There was a tree planting drive that saw the school distribute over 3,000 seedlings to the neighbouring local communities.

The visit was an opportunity to remind the students of the important role that the fence plays in conservation of the forests, water resources and wildlife within the Aberdares.

## Bongo man wins animal action award

"We are making a specific donation of Ksh 4.6 million for the fencing of Mau Eburu". he said.

"It will form the start of an on-going support policy for the fencing of Mau Eburu and is in line with our enduring commitment to sustainability," Mr Hutchinson added.

# Kenya pens in trees to save water lifeline

## East Africa drought

Fences are the latest tool being deployed to protect the forests vital for catching vapour, writes

A fence might not seem the most obvious solution to a water crisis, but it is among Kenya's hopes in a battle against a drought that is affecting more than 12m people across east Africa.

A 400km fence – the result of a 20-year fundraising effort by a charity in partnership with the Kenyan government – encircles the Aberdare Conservation Area, home to 3,000 elephants and some of the world's last remaining bongo antelopes. It is a favourite destination for thousands of sightseers, who come to see the treetop lodge where Princess Elizabeth became queen upon hearing of the death of her father George VI while she was visiting Kenya in 1952.

Aberdare's greatest value, however, lies not in tourism but in its role as one of Kenya's five "water towers" – forested uplands that "catch" vapour and help generate rainfall.

Millions of people rely on the water that flows from these green hills, including smallholder farmers, northern herders and families in Nairobi, as well as commercial tea and flower industries.

Hydroelectricity accounts for 58 per cent of national power supply. Scientists put the value of water from the forested hills at \$130m a year, according to an environmental assessment published by the UN environment agency this month.

The fence, which pens in trees and wildlife and keeps people and cattle out, is a key part of efforts to secure Kenya's water supply. Better management of the ecosystem by the use of fences such as at Aberdare is crucial to encourage rainfall and boost rivers in a region that faced alternate drought and flooding, say environmentalists.

"The condition of forests themselves can have an influence on... extreme [weather] events," the UN's Food and Agriculture Organisation said in a report last month. It added that deforestation and poor management could increase flooding and landslides during heavy rains.

Colin Church, of Rhino Ark, a charity that started the project at Aberdare, said: "The fence is just a tool. The whole point is management. These water towers can't just be left."

The \$9.3m electrified fence has contributed to an increase in forest cover.

Despite a presidential ban on felling trees on state land, illegal logging has long depleted forests. Deforestation has caused severe degradation of watersheds, increasing erosion and silting, reducing river flow and

disrupting hydropower.

According to the UN-funded environmental assessment, the fence has allowed indigenous forest cover to increase by more than 20 per cent in the five years to 2010 by deterring loggers and farmers and allowing the land to regenerate. As a result, Aberdare's rivers are "more stable" than those

of nearby Mount Kenya.

Stephen Kusero, who grew up amid bamboo forests that have long since disappeared, is one of about 40,000 farmers who have plots beside the new fence. He used to beat drums to scare off the elephants, monkeys and bushbuck that regularly destroyed his plot of cabbage, carrots and kale.

"The fence is a gift to the community all around. Formerly, we couldn't harvest anything – the animals were consuming the whole food crop. But [since] the fence came, no animals are coming to our farms," said Mr Kusero at a seedling nursery.

Now that it is better

protected for farming, local land prices have quadrupled. Mr Kusero's community, one of eight who helped to build the fence, has planted 92,100 trees in the forest in the past five years. Farmers have also been encouraged to take up everything from beekeeping to fish farming to take pressure off the forest.

Rhino Ark and the Kenyan government now want to build fences around Mount Kenya and at Mau Mount Eburu, another important water catchment area.

The government has committed funds for these new fences, and last month pledged \$150m for

irrigation and rainwater harvesting throughout the north, where herders face a food crisis as livestock die and grazing pasture dwindle away.

Kenya has already planted more than 455m trees as part of a Kenyan-inspired global effort that began in 2007 to plant a billion trees every year.

Long-term, however, environmentalists say Kenya will manage scarce water only when Kenyans pay more for it.

"Water is one of those commodities that people have taken for granted. If the price of water reflected its value, then people would respect it," said Barney Barrow, director of

Eco Centric Kenya, an environmental consultancy.

He said higher usage fees should be channelled back into protection of ecosystem services and the water they provide. He added: "The sad truth is Kenyans will not realise the value of water until they are fighting each other over it."

## Finlays take over plastic post machines

Rhino Ark is re-launching its plastic fence post initiative in partnership with Finlays, the horticultural export company.

Rhino Ark pioneered the conversion of plastic waste from flower farms in 2000 after it purchased a 20-year-old agronomer and extruder to make 4-inch posts from a well-established plastics company in England.

Naivasha flower farmer, the late Mike Higgins of Kijabe Ltd put the machine to work on a voluntary basis as an added contribution to Rhino Ark's conservation efforts.

As a result of the success with the first machine in 2003, the same English company, KweenBee, donated a second larger unit that is capable of extruding 6 inch posts.

Both units have now been installed at Finlays' Kingfisher Farm in Naivasha and are producing posts to be used in Mt Kenya and Mau Eburu. Under an agreement with Homegrown, the posts are being provided at cost to Rhino Ark.

Plastic posts have proved their resilience and have an indefinite life span as compared with wooden posts that eventually disintegrate.

Plastic posts have other benefits: they are cheaper than wood; and they do not need expensive plastic insulators as current flow using U nails creates no electricity transfer in plastic. Also plastic posts bend back upright if bent by elephant or other threat whereas wooden posts snap and have to be replaced.

Since 2000, when plastic posts were introduced into the build process, the completed Aberdare fence – nearly 400 kms long – contains one in five posts made from plastic waste. The entire fence contains 100,000 posts of which 20,000 are plastic.

"We have set a challenge to the flower industry to create value out of waste", said Colin Church, Chairman of the Rhino Ark Management Committee. "Rhino Ark is a living demonstration that where there are alternatives to wood from trees, they can be used effectively", he added.
