

### RHINOCEROSES REPORTING TO THE 74<sup>th</sup> MEETING OF THE STANDING COMMITTEE VIET NAM

Date of report: 01/2022

#### BASIS

- Decisions 18.110, 18.111 on Rhinoceroses (Rhinocerotidae spp.), adopted by CoP18 (2019)

- Resolution 9.14 (Rev. CoP17) on Conservation of and trade in African and Asian rhinoceroses, in particular paragraphs 1 e) and 2 d)

#### MAIN CONTENTS

At the request of Viet Nam CITES MA on 12/2021, the Department of General Affairs -Supreme People's Court of Viet Nam, Department of Environmental Police – Ministry of Public Security, Administration of Customs – Ministry of Finance submitted their reports per required by above-mentioned decisions. Viet Nam CITES MA also consulted local NGOs for information as reference to the report. The report comprises of 4 sections, including: Data of seizures, forensic examination, investigation and modus operandi related to illegal rhinoceros horn trade as following:

#### 1. Seizures and criminal procedure

The data collected from the mentioned authorities does not represent national data in the meantime. However, the data denotes the situation of illegal trade of rhinoceros horns to Viet Nam, which is used to be analyzed by national management, enforcement agencies and judicial bodies upon relevant matters. Data on seizures and criminal procedure are listed in details:

- Statistics on seizures of rhinoceros horns carried out by Viet Nam Department of Environmental Police 08/2019 - 01/2022 is attached as **Table A1**.

- Statistics on seizures of rhinoceros horns carried out by Viet Nam Administration of Customs is attached as **Table A2**.

- Statistics on criminal procedure (resolved cases) of Article 244 of the Penal Code as Violation of regulations on management and protection of endangered, rare, precious animals from 08/2019 to 12/2021 are presented in **Table A3**. Article 244 regulates criminal penalty not only for rhinoceroses, but also other listed species fell under the same category. For rhino horn illegal trade, penalty is stipulated with a fine up to 15 billion VND, punishment up to 15 years in prison.

Table A3 describes the total number of cases, including total number of defendants prosecuted under Article 244 related to animals under Group IB (List of domestic forest endangered, rare, precious fauna and flora) and Appendix I of CITES.



- Due to objective reasons, a complete statistics of seizures of rhinoceroses specimens in Viet Nam is not available. Viet Nam CITES MA instead requested for information from Education for Nature Viet Nam (ENV) on their recorded data from 2019 to 2021, attached as of **Table A5**. The provided information by ENV acts as reference along with this report, Viet Nam CITES MA is not responsible for its validity and accuracy.

#### 2. DNA sample submission to range states

Viet Nam CITES MA, in collaboration with Viet Nam CITES SA conducted the handover of 56 rhinoceroses specimen's samples to the Embassy of South Africa in Hanoi, 06/2021.

During 2019 - 2021, Viet Nam CITES SA has conducted a large number of DNA forensic examination based on collected rhinoceroses samples from domestic seizures. The number of examination carried out by Institute of Ecology and Biology Research (IEBR) has increased significantly overtime as 08 examinations in 2019, 11 examinations in 2020 and 19 examinations in 2021. This shows great efforts of Viet Nam CITES SA, in collabortion with enforcement agencies, to explore information for investigation procedure. The examination's results are presented in **Table A4**.

# **3.** Joint investigations and operations aimed at addressing member of organized crime network across the illegal trade chain

Per report of Administration of Customs, during 2019 - 2021, the Administration of Customs has actively participated and contributed to a number of regional, international operation in combatting illegal wildlife trade. The operations are listed as:

- Operation Praesidio (2019) launched by World Customs Organization (WCO),

- Operation Thunderball (2019) and Thunder (2020) co-organized by WCO and INTERPOL,

- Operation Mekong Dragon phase II (2020) and phase III (2021) co-initiated by Viet Nam Customs and China Customs,

- Operation Golden Strike (2021) launched by INTERPOL.

### 4. Analysis of modus operandi in illegal trade in rhinoceros specimens

According to the Department of Environmental Police (01/2022), in the past years, the frequently used modus operandi by traffickers in illegal trade of rhinoceros specimens is to taking advantages of electronic customs declaration procedure, the customs risk management to falsely declare the goods; and to taking advantages of transit procedure in foreign countries to re-establish customs documentation to conceal its country of origin. In terms of seaway transportation, the most frequently used modus operandi is to transport through multiple ships and seaports via different countries before arrived to Viet Nam. Regarding to airway transportation, traffickers are found falsely declared in



customs clearance, with the purposes to be classified as green line, yellow line to avoid customs control in entering Viet Nam. Once detected, the suspects often rejected the receipt of the consignments by the reasons that foreign partners sent the goods by mistake, and falsed to complete the customs declaration./.

1	07/03/201 9	Hanoi	334 grams	On March 7 <sup>th</sup> , 2019, Nam Tu Liem police seized 334 g of white rhino horn and arrested two suspects at a coffee shop in Nam Tu Liem district. They were the buyer and seller involved in the rhino horn transaction. The seller got the contraband from an unknown Laotian in January 2019. He had been convicted for the violation of larceny in the past. On July 23 <sup>rd</sup> , 2019, Nam Tu Liem District Court sentenced the seller to 12 months' imprisonment, and the buyer was sentenced to a suspended sentence of 12 months, applied Point C Clause 1, Article 244 of Criminal Code. The rhino horn was later destroyed ( <i>Case ref.14016/ENV</i> ).
2	12/4/2019	Hanoi	14.6 kilogram s	On April 12 <sup>th</sup> , 2019, Hanoi Anti-smuggling Police at Noi Bai International Airport discovered 14.6 kg of rhino horn in the checked baggage of a South African passenger. The subject reportedly smuggled the rhino horns from South Africa, transiting through Singapore before arriving in Vietnam. The man confessed that he was hired to transport the rhino horn by a man in South Africa and intended to deliver the horns to a Vietnamese person. On October 22 <sup>nd</sup> , 2019, the subject was convicted and sentenced to a prison term of 10 years. The subject appealed, but then withdrew his claim <i>(Case ref.</i> <i>14175/ENV)</i> .
3	30/5/2019	Quang Ninh	6.9 kilogram s	On May 30 <sup>th</sup> , 2019, National Criminal Police (C02), in cooperation with Quang Ninh Provincial Police, seized two white rhinoceros <i>(Ceratotherium simum)</i> horns weighing 6.9 kg from a home in Mong Cai. The subject was a woman who lived in Mong Cai, but originated from Hai Phong. During the subsequent investigation, two more subjects were arrested. On January 11 <sup>th</sup> , 2020, the three subjects were convicted by Quang Ninh Provincial Court. Two of the subjects were sentenced to a prison term of six years and seven years respectively, while the third subject received a three-year suspended sentence <i>(Case ref. 14460/ENV)</i> .
4	11/7/2019	Ninh	0.83 kilogram	On July 11 <sup>th</sup> , 2019, Ninh Binh Economic Police seized 0.83 kg of rhino horn from a taxi outside a hotel in Gia



		Binh	S	Vien District. The rhino horns were brought to the hotel by a passenger in the taxi who reported intentions to sell to an unknown buyer at the hotel. After confiscating the rhino horns, the police checked the subject's house and found suspected animal bone TCM. On March 12 <sup>th</sup> , 2020, the subject was convicted by Gia Vien District Court and sentenced to a suspended term of 18 months, with 36 months of probation. The subject was also fined VND 50 million ( <i>Case ref. 14672/ENV</i> ).
5	25/7/2019	Hanoi	126.5 kilogram s	On July 25 <sup>th</sup> , 2019, Hanoi Anti-Smuggling Police, Noi Bai Customs, and Hanoi Customs discovered 126.5 kg of rhino horn on a flight from Dubai. The cargo arrived at Noi Bai Airport on July 14 <sup>th</sup> , 2019, in two shipments with the same consignee. However, it remained unclaimed, and was subsequently inspected. The rhino horns were hidden in gypsum, in an effort to prevent detection from airport scanners. A subject was identified as the person responsible for trafficking the rhino horns. On December 4 <sup>th</sup> , 2021, the subject was convicted by the Hanoi City Court and sentenced to 14 years in prison – the highest punishment for a wildlife criminal in Vietnam to date. The rhino horns were destroyed <i>(Case ref. 14737/ENV)</i> .
6	20/8/2019	Hanoi	612 grams	On August 20 <sup>th</sup> , 2019, Hanoi Environment Police and Hanoi Investigation Police arrested a man with 261 g of rhino horn, found in the consignee store area on bus company premises. After the initial seizure, police inspected the man's house and discovered another 351 g of rhino horn and 28 kg of ivory. The subject's wife was also arrested alongside three other accomplices. One of the subjects submitted CITES import documentation for the horns, although it did not correspond with the confiscated rhino horn. On February 14 <sup>th</sup> , 2020, all five subjects were convicted by a Hanoi Court of wildlife trafficking. Four of the individuals received prison terms ranging from 30 months to 5 years while the fifth subject received a 30-month suspended sentence and five years of probation ( <i>Case ref. 14889/ENV</i> ).
7	07/11/201 9	Hanoi	1.865 kilogram s	On November 7 <sup>th</sup> , 2019, the Control Customs of Noi Bai Customs and Imported Luggage of Noi Bai Customs, in cooperation with Hanoi Anti-Smuggling Police and Hanoi Economic Police seized 1.865 kg of black rhino <i>(Diceros bicornis)</i> horn in the carry-on luggage of a passenger on a flight originating from Angola. On June 1 <sup>st</sup> , 2020, the subject was convicted by a Hanoi Court and sentenced to a prison term of five years. The rhino horns were destroyed <i>(Case ref. 15293/ENV)</i> .
8	02/03/202 0	Can Tho	28.7 kilogram	On March 2 <sup>nd</sup> , 2020, Can Tho International Airport Customs seized 11 pieces of rhino horn weighing 28.7 kg,

The flight was redirected from Tan Son Nhat International Airport in Ho Chi Minh City, due to the Covid-19 epidemic prevention policy. On December 29 <sup>th</sup> , 2020, the subject was convicted by Can Tho City Court and sentenced to a prison term of 12 years and six months. The subject also received an additional fine of VND 100 million. The rhino horn will be destroyed. The subject later appealed. On April 29 <sup>th</sup> , 2021, the High People's Court in Ho Chi Minh City decided to turn down the subject's appeal <i>(Case ref. 16018/ENV)</i> .

The rhino horn pieces were hidden in two check-in bags belonging to a Vietnamese man arriving on a flight that originated in Mozambique. One subject was arrested. On November 20 <sup>th</sup> , 2020, the subject was convicted by Tan Binh District Court and sentenced to a prison term of six years. The rhino horn is to be destroyed. On March 8 <sup>th</sup> , 2021, the People's Court of Ho Chi Minh City opened an appellate trial of the case, based on the subject's appeal to reduce the penalty, however, the court upheld the initial judgment <i>(Case ref.</i> <i>16037/ENV)</i> .

On November 16 <sup>th</sup> , 2021, Hanoi High Court opened the trial and decided to turn down the subject's appeal. The rhino horn was transferred to the State Reserve Agency under the Ministry of Finance ( <i>Case ref. 18737/ENV</i> ).

All evidence was pending transfer to a scientific agency specializing in wildlife ( <i>Case ref.</i> <i>19547/ENV</i> ).

The container originated in South Africa, and the owner had declared the goods as wood ( <i>Case ref. 20572/ENV</i> ).

The shipment arrived at the port in February 2021 but nobody came to claim it <i>(Case ref. 22072/ENV)</i> .
