

## ELEPHANTS, RHINOS / HIPPOS / FELINES

**AFRICA** 

#### **ANGOLA**

#### Thursday, December 1<sup>st</sup>, 2022 Quatro de Fevereiro International Airport, Luanda Province, Angola

45 kg of ivory and 4 kg of big cat teeth seized from the luggage of 2 Vietnamese passengers bound for Dubai via the United Arab Emirates.

#### **KENYA**

#### November 16, 2022 Nairobi, Nairobi County, Kenya

Following a missing person report filed at the Muthangari police station, Yang Changgui's house was searched and his lifeless body was discovered, along with 78 sections of elephant tusk and some carved ivory, 2 rhinoceros horns, 65 lion teeth and 160 lion claws (*Panthera leo*, Appendix II), stamps in the name of Hua Xoang Development Limited, Stanbic Bank chequebooks, 2 cell phones (Huawei and Lenovo), a printer and an electric saw. The body was taken to the morgue for autopsy. Nation (Kenya), November 17, 2022.<sup>2</sup>

#### **MOZAMBIQUE**

#### December 6, 2022 Maputo, Maputo Province, Mozambique



Seizure of 10 kg of rhinoceros horns, 280 kg of raw ivory, 340 kg of bones, claws and skulls (12) of lion (*Panthera leo*, Appendix II) in the hands and home of a Mozambican man. According to SERNIC (Serviço Nacional de Investigação Criminal), the loot, which the man says he "kept" on behalf of a Vietnamese who has not given him any news for over a year, was awaiting shipment to Asia via Maputo airport.

The trafficker is believed to be linked to a Vietnamese gang arrested in May in Nigeria (see "On the Trail" n°36 p.10).

#### **UGANDA**

#### November 5 and 22, 2022 Nansana and Kampala, Central Region, Uganda

- Katushabe Patrick, a high-ranking army officer, was arrested in a guest house. He possessed 28.9 kg of raw ivory and 2 hippopotamus teeth (*Hippopotamus amphibius*, Appendix II) weighing 1.65 kg. His accomplices fled the scene.

- He was fined 10 million shillings (2,640 US\$) or 6 years' imprisonment for illegally possessing protected animal parts and 5 million shillings or 5 years' imprisonment for conspiring to commit a crime.

#### **TOGO**

#### October 13 and 14, 2022 Lomé, Maritime Region, Togo

Arrest of 3 thugs well versed in trafficking and with well-filled address books. They include Moazu Kromah, alias Kampala Man, extradited to the USA and sentenced to 63 months in prison (see "On the Trail" n°37 p.38). Moustapha Seck, the Senegalese jeweller, Oumaru Kamara and Mamoudou Kamara,



who it is unclear whether they are from Guinea or Liberia, or both, were caught in possession of 50 carved ivories, an elephant tail and 11 lion teeth (*Panthera leo*, Appendix II). The lion teeth used to make pendants came from Ghana and Nigeria, and the elephant hair used to make bracelets from Cameroon. The operation is credited to OCRTIDB (Office central de répression du trafic illicite des drogues et du blanchiment) and MERF (Ministère de l'Environnement et des Ressources Forestières), with support from EAGLE Togo.


#### ZIMBABWE

#### Year 2022 Zimbabwe

Official toll for the year 2022.

- Poaching of 25 elephants, 7 rhinoceros and 4 lions (*Panthera leo*, Appendix II).
- Seizure of 123 elephants tusks or tusks sections, 3 rhino horns, 25 firearms and 174 rounds of ammunition.
- 5,530 traps dismantled.
- 167 poachers convicted.

#### **UNITED STATES OF AMERICA**

#### October 17, 2022 New York, State of New York, United States of America

The Kenyan citizen named Mansur Mohamed Surur, alias Mansour, was sentenced to 54 months in prison. He committed a crime punishable by 45 years in prison. #### December 14, 2022 New York, State of New York, United States of America

A Guinean citizen named Amara Cherif, alias Bamba Issiaka, was sentenced to 57

months in prison. He was accused alongside Moazu Kromah (alias Ayoub), alias Ayuba, alias Kampala Man, and Mansur Mohamed Surur for organising the transport, smuggling and sale of 190 kg of rhinoceros horns and over 10 tonnes of elephant ivory. The horns retail for 3.4 million US\$ and the tusks for 4 million US\$. Between March and July 2018, the African crime syndicate shipped 2 "test packages" containing one black and 2 white rhino horns to New York State in the United States.

Moazu Kromah was sentenced to 63 months in prison on August 18, 2022 (see "On the Trail" n°37 p.38).

In the context of overwhelming evidence presented in the indictment, strong links between wildlife and heroin trafficking, and the means used to obtain their extradition, the sentences handed down by New York's Southern District Court seem light.

The 3 Asian rhinoceros species are in Appendix I: the Indian rhinoceros *Rhinoceros unicornis*, the Sumatran rhinoceros *Dicerorhinus sumatrensis*, and the Javan rhinoceros *Rhinoceros sondaicus*.


#### End of November 2022 Quatro de Fevereiro International Airport, Luanda, Luanda Province, Angola

Over the weekend, a Chinese woman flies to Dubai with 13 horns in 2 suitcases. She was intercepted at the last minute in the departure lounge. Novo Jornal, November 21, 2022.<sup>1</sup>

#### **MOZAMBIQUE**

#### October 5, 2022 Maputo, Maputo Province, Mozambique



Twin City extends over 1,379 km<sup>2</sup> to the north of the Greater Lebombo Conservancy, the Kruger Park's cross-border buffer zone between South Africa and Mozambique.

#### **ZIMBABWE**

#### October 12, 2022, January 11 and February 21, 2023 Chipinge Safari Area and Chipinge, Manicaland Province, Zimbabwe



The black rhino was riddled with bullets as he quenched his thirst at the Chidimayi watering hole. "A trail of blood was seen emanating from the watering hole along the river to the place where the carcass was discovered," says the police spokesman. On January 11, following a tip-off, ZimParks ranger Johane Guzha was arrested at his home.

On February 21, in court, he claimed to have shot the rhinoceros in self-defence. He was nevertheless sentenced to 10 years in prison for shooting the animal and 10 years for taking his horn. The sentences will run concurrently. The horn has not yet been found.

#### Beginning of October 2022 Pilanesberg National Park, North West Province, South Africa

Rhino dehorning in Pilanesberg continue to protect rhinos from poaching, but the dehorned horns are not always protected from trafficking.

#### REPEATED OFFENCE October 18, 2022

#### Sannieshof, North West Province, South Africa

The International Rhino Poaching Squad was driving a white Polo on National Highway 14. It was made up of an ex-policeman from Botswana and 3 nationals from Nigeria, Zimbabwe, and South Africa. It was stopped in its tracks by the Vryburg flying squad and canine squad, and the Sannieshof police. Inside the car were 2 rhino horns and a firearm silencer. Marumo, the ex-police officer, had already been arrested for trafficking horns and was released during the Covid-19 court paralysis. The quartet is behind bars.

#### October 20, 2022 Middelburg Toll Plaza, Mpumalanga Province, South Africa

On National Highway 4, a Toyota minibus was inspected at a tollbooth. Under the hood were 2 suspicious packages. They contained 2 rhinoceros horns valued by the authorities at 2 million rand (111,625 US\$) on the local market. The driver and sole occupant of the minibus was taken into custody. According to him, the rhino had been poached 2 days earlier in the Kruger.

#### October 23, 2022 KwaZulu-Natal Province, South Africa



The Zululand Rhino Orphanage welcomed a 105 kg, 6-week-old rhinoceros whose mother fell prey to poaching.

#### November 15, 2022 Skukuza, Kruger National Park, Mpumalanga Province, South Africa Sentence of Silvester Sidney Zitha, age



40, to 25 years in prison, 2 for breaking and entering, 5 for illegal possession of a caliber 458 firearm with a silencer, 2 years for the illegal possession of ammunition, 10 years for poaching a rhinoceros, 2 for carrying a dangerous weapon (ax), and 4 for conspiracy to commit a crime. Some sentences are running concurrently and the effective prison sentence is 17 years. In October 2018, he had been caught in the act of poaching after a 3 km chase with rangers from the Tshokwane section of the Kruger. He was in possession of 2 horns. He was accompanied by an accomplice who was released on bail, failed to respond to court summons, and is now presumed dead.

#### November 18, 2022 Skukuza, Kruger National Park, Mpumalanga, South Africa



At age 34, Sipho Titus Khosa is the rhino desperado. He was sentenced to 54

years in prison. As some sentences are running concurrently, the actual period of incarceration will be 37 years. In September 2016, in the Stolznek section of the Kruger, he had been surrounded in the bushes by a patrol. Between him and a partner, authorities seized a firearm with a silencer, 2 magazines with 33 rounds of ammunition, an axe, a survival bag, and 2 fresh horns. They were released on bail and did not respond to any further court summonses. Four months later, Khosa was at it again. He was with 2 new partners, still in the

Stolznek section of the Kruger, and after a chase by helicopter and on land, they had once again been surrounded by rangers. They had a firearm with silencer, an axe, and 3 rhino horns. This time, he was denied bail, unlike his 2 accomplices Francisco Mlambo and Sam Lejane.

#### November 22, 2022 Skukuza, Kruger National Park, Mpumalanga Province, South Africa



Sentencing of 2 Mozambican nationals to 6 years in prison. They had entered the

Tshokwane section of the Kruger with the intention and means of poaching one or more rhinos (see "On the Trail" n°36 p. 46).

#### November 24, 2022 Skukuza, Kruger National Park, Mpumalanga Province, South Africa



**Mpumalanga Province, South Africa**Sithlangu had been spotted with an automatic weapon slung over his

shoulder in the Stolznek section of the Kruger by a helicopter flyover. Arrested by a ground patrol, he was also found to be in possession of ammunition and other useful hulling tools. He was released on bail and never again responded to court summonses. In February 2022, he was caught up in a raid and sentenced by the specialized court to 14 years in prison for breaking and entering the Kruger, possession of a firearm, prohibited ammunition and a dangerous weapon (an axe), and premeditated rhino poaching. The sentences are combined for a total of 11 years.

The Aspinall Foundation team urgently dehorned 4 rhinos in a private reserve where poachers were spotted.

#### Saturday 3 or Sunday 4, December 2022 Khamab Kalahari Reserve, North West Province, South Africa. Border with Botswana.

The reserve's oldest male black rhino was poached and stripped of his horns by raiders who, despite the mobilization of a helicopter, drones, several anti-poaching teams and canine units, managed to escape to Botswana.

#### December 6, 2022 Skukuza, Kruger National Park Mpumalanga Province, South Africa



Kruger rangers Hendrick Experience Silinda and Archieve Musa Mlambo

sentenced to 7 years in prison. In their camp, the SAPS had seized in 2019 a large-calibre firearm with the number erased, with the ammunition to go with it, and 3 hunting knives. It is not known whether they themselves intended to poach, or whether they had introduced all the necessary equipment into the park for accomplices from outside. At the bar of the special rhinoceros court, they said they were the victims of a frame-up.

#### December 8 and 14, 2022 Ermelo, Mpumalanga Province, South Africa



The Toyota Fortuner was on the radar. It was stopped by the SAPS. Two men tried to escape. Four horns were found under the hood in the presence of the 2 suspects. Junior Chauke was released on 10,000 rand (590 US\$) bail, subject to conditions. Prince Ntsako Letswele remains in custody. The horns weigh 14.6 kg. They are valued at 876,000 rand or 3,500 US\$/kg, which in market conditions seems artificially undervalued and likely to dissuade would-be poachers!

SAPS, December 13 and 15, 2022.15

#### December 9, 2022 Leyden, Limpopo Province, South Africa

After the poaching of 2 rhinos, the hunt for information began. SAPS, private security guards and witnesses were mobilized, and 5 men were eventually arrested. Aged between 25 and 40, they were in possession of firearms with silencers, ammunition and 2 butcher's knives, and the SAPS have every reason to believe that the horns seized from their red Volkswagen came from the night's carnage. DNA confirmation is awaited. SAPS, December 10, 2022.<sup>16</sup>

#### December 9, 2022 Limpopo Province, South Africa



Arrival at the orphanage, blindfolded and ear plugged, of a new little resident, 4/5 months old, an orphan, dead set against humanity, throwing everything away, refusing bottles and approaches from the caretakers, fortunately agreeing to drink from a soup tureen and eat a little grass.

#### FAMILY AFFAIRS / REPEATED OFFENCE December 12, 2022 Bronkhorstspruit, Gauteng Province, South Africa




- A new trial for Gideon van Deventer, who is already serving a 10-year prison sentence (see "On the Trail" n°36 p.48). A whistleblower who deciphered court records informed the courts in June 2022, 8 years after the events, that Gideon, brother of Nicklaas van Deventer, who is serving a 15-year prison sentence, had escaped prosecution and conviction thanks to the complicity of the prosecutor at the time, Solly Leballo, for illegally possessing 2 firearms with silencers and 46 rounds of high-calibre ammunition able to penetrate the brains of rhinos. In 2018, Leballo was caught by elite police officers negotiating the dropping of charges against a murderer for the sum of 100,000 rand (7,000 US\$). He immediately resigned from his prestigious post before "being resigned".

His corruption trial has not yet been held. The amount of the bribe Leballo received from Gideon van Deventer for dropping the charges of possessing and transporting firearms and ammunition is not known. At the end of 2006, all managers of private reserves and national parks housing rhinos in South Africa were sent "High Alert" posters with portraits of Gideon van Deventer, his brother Nicklaas and Gert Saaiman, helicopter pilot and director of Saaiman Hunting Safaris. The 3 men were wanted for poaching 22 rhinos in the Kruger Park, the Hluhluwe-iMfolozi Park and in private ranches in Komatipoort and Bela-Bela. They were considered armed, dangerous and likely to shoot to evade arrest. "Be on the alert if you see a low flying helicopter or fixed-wing aircraft over the parks." Arrested in 2006 and sentenced in 2007 to 10 years in prison, 2 of which were suspended, Gideon van Deventer had been released on parole in 2011.

Prosecutor Leballo therefore knew in 2015 that he was protecting a serial rhino killer.

 Gideon van Deventer sentenced to 8 years in prison for possession illegal of 2 firearms and ammunition and 8 years for transporting 2 firearms and ammunition. The 2 sentences run concurrently.

#### December 20, 2022 Bronkhorstspruit, Gauteng Province, South Africa

Onward Muchangowa is sentenced to 7 years' imprisonment for conspiracy to

commit rhino poaching, 8 years' imprisonment for rhino poaching, acting in common purpose with the van Deventer brothers, and 5 years' imprisonment for the joint possession of 2 rhino horns. The sentences run concurrently. He had been arrested in January 2017 with the van Deventer brothers (see "On the Trail" n°16 p.65) and remained in custody awaiting trial. Muchangowa is said to have acted as


a commercial agent for several poaching gangs. He was a horn seller. He sold some of them on WhatsApp. Sometimes 7 or 8 people would fight over the privilege of winning the sale.

Overspeed in KwaZulu-Natal: 228 in provincial parks, 16 in private reserves.

"This year's outcome shows that collaboration between conservation authorities, the South African Police Services, revenue authorities and international agencies works. We believe that if provincial authorities in KwaZulu-Natal follow our model, they will be able to significantly curb rhino poaching in their provincial parks before it is too late," said Minister Creecy

#### **NAMIBIA**

#### October 4, 2022

#### Otjiwarongo, Otjozondjupa Region, Namibia

A black rhinoceros was dehorned for preventative purposes in a Kunene region reserve. The 12 kg horn was then placed in a batch with 5 other horns but soonafter disappeared. A PRU (Protected Resources Unit) agent named Salatiel Simon was sent on Friday, September 30 to submit the batch to the Otjiwarongo police station, but only handed over 5 horns. After failing to explain why the 6th was missing, he was put in prison. On Friday, October 28, the head of the PRU revealed that the horn was found in Angola and that the policeman had resigned on Wednesday, October 19. Against the advice of the public prosecutor's office, Simon was released on Thursday, December 1 on a 590 US\$ bail - a puny sum compared to the value of a kilo

Wang Hui, leader of the Windhoek gang that made the headlines in "On the Trail" between 2014 and 2019, fled this Monday at around 11 a.m. Along with other convicts, he was enrolled in a supervised work outside camp prison north of Windhoek. He pretended to want to go to the toilet disappeared. and



Some say he took off in a Mercedes, others say in a pick-up truck. He was serving 20 years in prison for attempting to smuggle 14 horns and rhinoceros and a leopard skin in March 2014. Wang Hui and his 3 henchmen were sentenced in September 2016 to between 9 and 11 years in prison. They appealed and were sentenced to 20 years in prison (see "On the Trail" n°4 p. 66, n°5 p. 73, n°6 p. 65, n°9 p. 62, n°10 p. 47, n°11 p. 65, n°14 p. 68 and n°25 p. 78).



## THAILAND AND UNITED STATES OF AMERICA

"On the Trail" has been tracking Teo Boon Ching since 2015. Despite all his precautions, such as his looks and his alibis of travelling for pleasure between Africa and Asia, "Godfather" was hooked by 2 special agents of the US wildlife services, one of whom claimed to live in Manhattan, New York, trafficking in Madagascar radiated tortoise (Astrochelys radiata, Appendix I) and spotted pond turtle (Geoclemys hamiltonii, Appendix I), and having a good knowledge of the smuggling manners and a desire to diversify into rhinos. During the summer of 2019, the American justice system accumulated enough photos, videos, telephone and email exchanges for the Malayan or Thai police to take an interest in this elusive character. . Godfather was arrested in Bangkok on June 29, 2022. It was in the Thai capital that on August 23, 2019, one of his partners in wildlife trafficking delivered 12 African rhino horns (2 black rhino, 10 white rhino) weighing 26 kg. The day before this transaction, Godfather, who was in Malaysia, or claimed to be, had received transfers in yuan via a Bangkok-based Chinese bank unknown to the tax authorities. The 12 horns were bought by the pseudo-buyer in Manhattan for 259,000 US\$ (i.e. around 10,000 US\$/kg) and Godfather demanded to be paid in yuan to better conceal the trafficking. To complete the picture, he planned to smuggle and transport around 73 kg of horns to the United States with American pseudo-clients on the basis of 725,500 US\$, i.e. nearly 10,000 US\$/kg.

- On October 7, 57-year-old Teo Boon Ching, who also used the aliases Zhang and Dato Sri, was extradited and placed under escort by at least 2 US special agents on a scheduled flight to New York. On arrival, he was brought before the US Attorney for the Southern District of New York and charged with trafficking in endangered species and money laundering.
- On September 19, 2023, Teo Boon Ching was sentenced to 18 months in prison, which the prosecutor said was a "substantial sentence" and proof of "the resolve of this Office to use every tool at our disposal to ensure the protection of endangered species." He was liable to 20 years' imprisonment. The investigation finally proved that Teo Boon Ching had conspired to smuggle, sell and transport to the United States at least 219 kg of rhino horn worth approximately 2.1 million US\$. #### **VIET NAM**

#### October 23, 2022 Dong Tinh, Vinh Phuc Province, Viet Nam

Five Chinese nationals working in the Bac Ninh province travelled to buy rosewood (*Dalbergia tonkinensis*, Appendix II). Arousing suspicions, the police decided to check them out. Sure enough, the men had no documentation authorizing their presence in Viet Nam. What's more, one of them, Chen Jian Fu, was wanted by Guangzhou customs in connection with smuggling 11.3 kg of rhinoceros horn. He found refuge in Tu Son, Bac Ninh province, thanks to an acquaintance born in the same town and living in Hanoi. They were all taken to the police station.

Chen Jian Fu is not the only Chinese trafficker to have gone into exile in Viet Nam: see for example "On the Trail" n°37 p.189.

He was wanted for his alleged involvement in the poaching and dehorning of a rhino in Kaziranga in January 2022 (see "On the Trail" n°35 p.41-42). When Kala was arrested, he was in possession of a large-calibre weapon and accompanied by Shamshuddin, his alleged accomplice.

#### December 15, 2022 Capital City of Prague, Czechia



Much ado - 24 rhinoceros horns seized in Prague in July 2013, and valued at nearly 4 million US\$ - about a judicial nothing,

after almost 10 years. The Vietnamese organisers and Czech shooters who carried out the point-blank slaughter of rhinos on Dawie Groenewald's farm in South Africa in 2013 have been sentenced to 1 to 3-year suspended prison terms and derisory fines following a chaotic judicial process. Instead of being considered as hunting trophies forbidden to any national or international traffic, the horns were destined to be smuggled to Viet Nam or sold to Prague's Vietnamese community.

The body of the 3-year-old tigress was drifting in the river on the edge of the park, which had just been reopened to the public on Saturday after 3 months behind closed doors. The news sent a chill down the spine of the park and sent forestry officials into a panic. The show was not what visitors were looking for. The alarm was sounded at 8 a.m. The body floating on the Pench River had all 4 paws amputated. According to a local rumor, ceremonies and manipulations of tiger paws by initiated sorcerers bring rain and wealth. The victim died of electrocution.

#### November 12, 2022 Hunasekuppe, Mysore District, State of Karnataka, India



This was the fourteenth poaching victim in Karnataka since the beginning of 2022. The tigress died on Saturday, November 12 in a trap in the Nagarahole Tiger Reserve, leaving 3 orphans to fend for



themselves in the forest. The news was initially reassuring. Aged 10 or 11 months, the tiger cubs were seen at 4:58 a.m. on Tuesday, November 15 sharing the carcass of a deer. Mahouts on the backs of domestic elephants continued to observe the movements of the survivors, and on Sunday, November 27, one of the tiger cubs was found dead with wounds to his neck, back, and front paws. He had apparently been attacked by a dominant male tiger. His body was burned in the presence of a representative of the NTCA (National Tiger Conservation Authority) and veterinary doctor Ramesh. Concern is now focused on the fate of the 2 surviving tiger cubs.
