- 6.—(1) Subject to the provisions of section 3 of this Ordinance Saving. nothing in this Ordinance shall affect the right of the Government to withhold the payment of donations which have been credited to the account of any person to whom this Ordinance applies.
- (2) Nothing in this Ordinance shall entitle any person to have further donations or contributions credited to his account for any period in respect of which donations and contributions have already been credited to such account under the provisions of the Principal Ordinance.

An Ordinance to protect the Borneo Rhinoceros.

Enacted by the Governor of Sarawak with the advice and consent of the Council Negri:—

- 1. This Ordinance may be cited as the Rhinoceros short title. Protection Ordinance, 1946, and shall come into operation on a day to be appointed by the Governor by notification in the Gazette.
- 2.—(1) Any person who kills, shoots or captures or attempts Offence to kill, to kill, shoot or capture any rhinoceros (R. sumatransis), badak, shoot or capture a rhinoceros or shall be guilty of an offence.
- (2) Any person who is guilty of an offence under this section Penalty. shall be liable on conviction to a fine not exceeding \$1,000 or to imprisonment for a term not exceeding six months or to both such fine and imprisonment.

An Ordinance to protect the Borneo Rhinoceros.

Enacted by the Governor of Sarawak with the advice and consent of the Council Negri:—

- 2.—(1) Any person who kills, shoots or captures or attempts Offence to kill, to kill, shoot or capture any rhinoceros (R. sumatransis), badak, shoot or capture shall be guilty of an offence.
  a rhinoceros or attempt to do so.
- (2) Any person who is guilty of an offence under this section Penalty, shall be liable on conviction to a fine not exceeding \$1,000 or to imprisonment for a term not exceeding six months or to both such fine and imprisonment.

### Objects and Reasons.

The rhinoceros has almost entirely disappeared from Sarawak and it is considered essential to protect the last few remaining specimens.

#### Kuching Dance Hall By-laws.

In exercise of the powers conferred on a Municipal Authority by section 6 of Part VI of the Municipal Regulations, the Kuching Municipal Board, with the approval of the Governor in Council, has made the following by-laws to be inserted into the Kuching Municipal By-laws immediately after Chapter XV:—

#### "CHAPTER XVA.

1. In these by-laws:-

Definition.

"the Board" means the Kuching Municipal Board;

"Dance Hall" means any premises or part of any premises habitually used for public dancing;

"manager" means a person who manages or carries on a Dance Hall

- 2.—(1) No premises shall be used as a Dance Hall unless Registration of licensed in that behalf by the Municipal Officer with the approval Dance Halls, of the Board.
- (2) A fee of \$30 per month shall be paid in advance for every licence issued under these by-laws and such fee shall be paid at such times and for such periods as the Municipal Officer may direct; provided that if the licence is at any time withdrawn by the Municipal Officer that proportion of the fee which represents the unexpired part of the period for which it was paid shall be refunded.
- (3) The Board may attach to any licence which it issues under these by-laws such conditions as it sees fit.
- (4) Every such licence shall state the conditions under which it is issued and in particular shall state:—
  - (i) The name and address of the manager.
  - (ii) The period for which the licence is in force.
  - (iii) The hours during which the Dance Hall may be kept open.
  - (iv) The maximum number of persons that may be admitted at any one time.
  - (v) The number of doors and exits to be provided.
  - (vi) The precautions to be observed in case of fire or panic.
